37.110 **SEVERABILITY**. **SUMMARY:** An ordinance legalizing the driving of golf carts within Pahrump, Nye County, Nevada.

AN ORDINANCE REQUIRING PERMITS FOR THE TRAVEL OF GOLF CARTS WITHIN PAHRUMP, NYE COUNTY; ESTABLISHING FEES: DESIGNATING STREETS: ESTABLISHING PENALTIES: SETTING THE EFFECTIVE DATE: AND ALL OTHER MATTERS PROPERLY PERTAINING THERETO.

The Board of Nye County Commissioners, acting as the Board of Trustees of the unincorporated Town of Pahrump, Nye County, Nevada, does hereby ordain as follows:

NOTICE OF ENACTMENT OF PAHRUMP TOWN ORDINANCE NO. 11

NOTICE IS HEREBY GIVEN that the Board of Nye County Commissioners, acting as the Board of Trustees of the unincorporated Town of Pahrump, Nye County, Nevada, at its regular meeting held on the 20th day of July, 1982, proposed Pahrump Town Ordinance No. 11, and at the Board's regular meeting held on the 4th day of August, 1982, adopted the said Pahrump Town Ordinance No. 11, which reads:

PAHRUMP GOLF CART ORDINANCE

- 11.010      SHORT TITLE. This ordinance shall be known as the Pahrump Golf Cart Ordinance.

- 11.020      PERMIT REQUIRED. Unless registered pursuant to Chapter 482 of the Nevada Revised Statutes, no golf cart may be driven on the designated streets located within the unincorporated limits of the Town of Pahrump without a permit attached to said golf cart, and issued pursuant to 11.030.

- 11.030      FEE. The County Assessor is hereby authorized to issue permits to all appropriate applicants and to charge a fee of FIVE DOLLARS (\$5.00). The permit shall be in such form as the County Assessor may deem practicable.

- 11.040      DESIGNATION OF STREETS. Every street and road located within the unincorporated Town of Pahrump, with the exception of

state highways, is hereby designated as an appropriate thorough fare for the travel of golf carts affixed with permits issued pursuant to 11.030.

**PENALTIES.** Any person operating a golf cart traveling within the unincorporated Town limits of Pahrump upon a non-designated street, or traveling without a regularly issued permit shall be guilty of a misdemeanor and shall be punished by a fine not exceeding TWO HUNDRED DOLLARS (\$200.00).
